## STUDENT RESPONSIBILITIES FOR MASTER=S THESIS

The table below and on the next page provides guidelines for when to complete the steps involved in a Master=s thesis. Time periods are based on the typical progress of students, or the latest time interval each activity must be completed in order to complete both the Master=s and dissertation within 4 full years (plus the following summer). Completing steps ahead of this schedule is strongly encouraged, except where regulations prohibit it (e.g., students cannot enroll in dissertations hours until after passing comprehensive exams).

By summer after first year	Approach faculty members to discuss and narrow down research topic and identify chair/advisor

By fall of second year	Begin meeting regularly with advisor to flesh out research ideas and methods
	Purchase thesis manual and review department=s and APA guidelines for proposal
During fall of second year	Develop thesis proposal (literature review, methods, hypotheses, analyses, etc.)

The table below and on the next page provides guidelines for when to complete the steps involved in a doctoral dissertation. Time periods are based on the typical progress of students, or the latest time interval each activity must be completed in order to complete both the dissertation within 4 full years (plus the following summer). Completing steps ahead of this schedule is strongly encouraged, except where regulations prohibit it (e.g., students cannot enroll in dissertations hours until after passing comprehensive exams). In particular, students who come in with a Master=s degree and completed a thesis elsewhere should function approximately one year ahead of this schedule.

During spring and summer of third year	Conduct literature search on dissertation topic
	Begin meeting regularly with advisor to flesh out research ideas and methods
By fall of fourth year	Develop dissertation proposal (literature review, methods, hypotheses, analyses, etc.)
	Approach two faculty members to serve as committee members
Across quarters (depending on program, and after passing Comp. Exam)	Enroll in dissertation hours
By winter of fourth year	Defend dissertation proposal
During winter of fourth year	Make any required changes in thesis proposal
	Get approval for research from Human Subjects Committee
	Begin data collection
Spring of fourth year	Complete data collection and begin data analysis
	Prepare thesis results and discussion, and convert proposal into final dissertation manuscript
By summer after fourth year	Defend dissertation
By end of summer after fourth year	Complete final revisions on dissertation
